

LETTER FROM THE PRESIDENT

These 2 guys and their merry band of helpers put on an award winning event which will allow us to continue our #1 Charity, The San Francisco Firefighters Local 798 Toy Program, distributing toys to children at Christmas time. Congratulations to Station 5 for winning Best Booth & Chili. A wonderful time was had by all.

As all of us are aware, the most recent Fire Department Headquarters' SNAFU is the failure of the Department to order replacement engines and trucks. The shocking fact is that the Fire Department has had millions of dollars for years but could not pull the trigger and order our rigs. The best explanation of it is when a member of the Board of Supervisors contacted me, he explained that when he questioned our command staff, it was like listening to a child who forgot their homework -"the dog ate it". It is what it is. We will make the best out of a bad situation. Say your rosaries that we don't have an earthquake in the next 365 days; that's the time it takes for the new apparatus to arrive - at least that's what the SFFD Administration says. NIOSH's report of the Revere Street fire where Firefighter Mike Estrada was severely injured should take 6 months. It's unfortunate that NIOSH had to come here to do a report. We would hope that the Fire Department will finally put to print (not an email) the findings of the Felton Street fire where 6 guys were injured. A manual so our firefighters can review it and actually have drills and have the Fire Department make adjustments for our safety.

Good luck to all who have friends or relatives who are taking the upcoming entrance exam. We as a union are somewhat mystified as to why there is no interview process for incoming firefighters. We are not aware of a department of any size that does not interview prospective firefighters. Let me give you an example. In a normal interview process, the interviewing board will ask prospective candidates ... "would you risk your life for someone you did not know, or your brother or sister firefighter in dangerous and/or hazardous conditions?" This is important; it should be mandatory to ask a prospective firefighter before he/she enters the Fire Department. What if the person said, "No, I will not risk my life - I'm here for the paycheck." We have done exhaustive research and have found that the person who you order a hamburger from at In-N-Out Burger goes through an interview process. I'll leave it up to you to decide.

I look forward to seeing those members who have passed muster at the upcoming 2nd Annual Bocce Tournament on October 9th.





Why is Getting Your FICO Score Important

Your FICO is not only used by financial institutions but can also be used to determine if you get a job, whether or not you can rent an apartment or qualify for insurance. The score itself is calculated from different types of data found in your credit report and is grouped into five different categories, with some categories having more impact on your score than others. Keep these factors in mind when trying to determine why your score is what it is

PAYMENT HISTORY

Paying bills on time matters. It is one of the biggest measures used in scoring and the easiest to control. A "clean" payment history (no delinquencies) and lack of adverse public records (bankrupscy, wage garnishment, liens, etc) will have a positive impact on your

AMOUNTS OWED

A ratio of overall debt to available credit is one of the main factors in determining a score. Keeping that ratio lower than 75% is satisfactory but below 30% is better. Fewer accounts with balances, a lower proportion of credit lines used (not maxing out credit cards) and having paid down installment loans (auto loans, etc.) can keep the ratio in your favor.

LENGTH OF CREDIT HISTORY

time and in good standing (paid on time, a low debtto-credit ratio) will have a positive impact on your have a negative effect.

score. Keep in mind that closing an unused credit card may work against you by increasing your debtto-credit ratio.

NEW CREDIT

Opening new credit accounts all at once, to lower a debt-to-credit ratio, or increase your overall available credit can work against your score -- lenders will submit inquiries to the credit reporting agencies and that activity will be noticed. The exception would be for those with payment history problems who need to re-establish credit history.

TYPES OF CREDIT USED

The number of accounts and the various types of accounts (credit cards, retail credit, auto loans, mortgages, etc.) will impact your credit score. While it is considered generally positive to have established Accounts that have been open for long periods of | accounts (as in credit history), too many accounts or frequent loans from some finance companies can


