

# PRESIDENT



As San Franciscans, we look in our history books and we remember that 1967 was the Summer of Love. By all indications, 2008 is shaping up into the Summer of Discipline for San Francisco firefighters. My feeling is that the Chief is expanding her role into that of "Sister Discipline" and using and expanding the Rules and Regulations to fit her ideal and reflect that in her philosophy for discipline. Current emphasis appears to be off-duty conduct. Many of the cases had no substantiation; whether it was no witness (es), or a rumor or an anonymous call to HQ. Yet with that minute bit of information, the Chief will start an internal investigation.

On April 16, 2008, we requested a Meet and Confer with the Administration to formulate a common sense policy for investigating off-duty complaints and to implement criteria for imposing discipline for off-duty conduct that actually does violate our Rules and Regulations. The Department has yet to respond to our request. We are doing all we can but it's difficult to change the philosophy of a regime with very strict, unbending, and apparently minimal faith in the men and women of Local 798. My opinion only.

The study packets were issued for the Lieutenant's exam. Many of the candidates are concerned that in its present format, the examination will not allow the candidates to express on paper their knowledge, skills, and abilities as firefighters and prospective officers. The experts who rate the exam will not be able to differentiate between superior, good and mediocre candidates. Local 798 is attempting to address the myriad concerns of our members regarding the exam immediately.

Good luck to all the candidates. Part of the test will be how one gets to the test site on the morning of the Bay to Breakers.

## Attention!!! Employee Health Premium Deductions

Beginning in Fiscal Year 2008-2009, employee premium co-payments will be deducted twice monthly, for a total of 24 deductions per year. Currently, employee co-payments are made on a biweekly basis, for a total of 26 deductions per year.

The first paycheck received in a month will have a premium deduction covering the first half of that month. The second paycheck received in a month will cover the second half of that month. There are two months each year in which employees receive a third paycheck in a month; there will be no deduction on that third paycheck. While the individual deductions will be normally higher, the overall annual deduction will be the same as there will be two fewer deductions.

Off-Duty Conduct - Departmental Discipline

Dear Chief-

Local 798 requests a meet and confer with the SFFD regarding Departmental Discipline based on members off-duty conduct. There have been a number of Departmental investigations centered around purely off-duty conduct with no seeming nexus to the job.

We request that a policy be established through the meet-and-confer process specifying the types of off-duty conduct which may be the basis for discipline, the criteria that will be used in determining when alleged off-duty conduct constitutes "acts detrimental to the Department" (Rules and Regulations §3922), and the criteria that will be used in determining when a complaint involving alleged off-duty conduct is sufficiently reliable to justify the Department investigating the alleged conduct.

Local 798 wants all members of the SPFD to be treated in a fair and consistent manner. Purthermore, we hope that this process will ensure that our members rights as private citizens are not violated by unnecessary and overly intrusive investigations.

Please respond as soon as possible in writing so we can schedule meetings to resolve this extremely important issue.

General Order 97-A-80 has been in effect since its inception either as a stand alone General Order or incorporated in the Vehicle Operations Manual Section 3.4. Bullet Point # 3 of the General Order described guidelines that "... will be followed for disciplinary action," when an individual is involved in an accident while operating a Department vehicle.

A new Vehicle Operations Manual was issued on February 15, 2008. The guidelines set forth in General Order 97 A-80 were removed from the manual. The removal of those guidelines constituted a unilateral change in a working condition for the members of Local 798. The Department did not meet and confer with the Department regarding the removal of those guidelines.

Per the Meyers-Milian-Brown Act, Local 798 requests an immediate meet and confer over the change in an eleven year practice. We also request that the Department immediately re-institute the discipline guidelines set fort in General Order 97-A-80 pending the outcome of the requested meet and confer. Respond as soon as possible in writing so we can set up a mutually agreeable meeting schedule

Re: Meet and Confer

Dear Chief,

Twice over the past month Chief Massetani and Vice-President Joe Moriarty have met at your direction to come to an understanding regarding the Chief's rights and responsibilities under Charger § 8.343. The discussion was focused on the practical application of the following language "...provided however, that the Chief of each respective department for disciplinary purposes may suspend such member for a period not to exceed 10 days for violation of the rules and regulations of his department."

As you know, the issue is two-fold:

- Suppression and non-suppression employees should be treated equally regarding time served for identical suspensions and
- The meaning of the word "day" as it applies to the Charter language. At a March 20 meeting, Chief Massetani and Vice-President Moriarty came to an agreement over both issues, pending your approval. Subsequently, I was notified that the Department had changed its position. A suppression member then served a 10 day suspension which covered a span of 15 calendar days.

Therefore, Local 798 requests an immediate meet and confer over the meaning of Charter § 8.343, the Department's application of the section, and its effect on our members.

## WARNING

Rules and Regulations for Sainthood Shall Be Restricted To and Administered Exclusively by the Vatican

I believe reasonably educated individuals would consider "the Firefighters Bill of Rights" (adopted state-wide January 1, 2008) to be a victory for unionism. Meanwhile, gray-haired Southern politicians who salivate while subordinating working conditions would seize at the mere mention of employees rights.

Well hold on Nellie!! We just crossed the Mason Dixon line again. Article 39, Section 3922 of the San Francisco Fire Department Rules and Regulations ACTS DETRIMENTAL TO THE WELFARE OF THE DEPARTMENT; The Department's version of the Patriot Act and its favorite tool for discipline regarding off-duty conduct is out of control. I doubt a more blatant anachronism of jurisprudence ever existed.

When we charge a firefighter with harm and acts detrimental (Section 3922) and then, attempt to lixiviate justice from the ashes it is contemptible to do so guided by personal morality. What are the guidelines and to what degree are the charges influenced by hear-say, media coverage, or worse yet, personal indignation? Would a chief officer be held to a higher standard and therefore more accountable than a firefighter? Do we inflict more harm for the Department by making public the private lives of employees?

Whenever the San Francisco Fire Department Rules and Regulations are revised, a number of archaic and arbitrary rules avoid pruning. It is time we abolish Rule 3922; it's an invasion of personal privacy and we should not be in the business of condemning firefighters for conduct in their private lives when it does not interfere directly with their performance in the sworn duties of a San Francisco firefighter.

Mistakes; sure, we're not saints. Let's move on. "..For all the harm that ere I've done. Alas! It was to none but me."

By now members included in the lawsuit Francis Kelly and Dennis Kruger et al vs. the City and County of San Francisco should have received your settlement package on Tuesday, April 22, 2008.

I would like to thank those who called the Union office regarding the settlement.

Yes, you are correct. The City has acknowledged their error with nearly all settlement packets.

Plaintiffs will receive a follow-up letter beginning with the week of April 28, 2008. Please read carefully and contact Frank Kelly at the Union office (415) 621-7103 for questions regarding the settlement. PLEASE DO NOT CALL OUR ATTORNEY, Diane Sidd Champion

Here are a few bullet points which

hopefully will belay your concerns:

- When will you receive your NEW packet? Sorry, we don't know as yet.
- Will the deadline of May 29 be extended? Yes
- Check carefully your lump sum calculations to ensure that they are correct. Remember, the City has already acknowledged that they have made mistakes.
- If you have not opted into the Comp Time portion of the lawsuit, you must do so NOW. FILL OUT the form and send it to Local 798's attorney Diane Sidd-Champion or City Attorney Dennis Herrera. Keep copies to protect yourself.
- Any monies that you gave to Deferred Comp is not included in the settlement. The settlement is based

solely on what was paid in lump sum payouts that did not include T&E, retention pay and/or terrorism response training pay.

- Repeat the process when receive your new packet which will contain a self addressed return envelope.
- When you receive your new packet there will be a release form included.
   Sign this form releasing the City of any further litigation. You must do so to receive your settlement portion of the lawsuit.
- DO NOT opt out of any part of the lawsuit. The City has offered all plaintiffs the option to opt out of your portion of Vacation Pay. Please ARE THEY KIDDING? They owe you money – COLLECT IT!! OPT IN FOR EVERYTHING!
