

# LETTER FROM THE PRESIDENT



Dear Brothers and Sisters.

On the front cover of this issue you will have seen the Speaker of the House, San Francisco's own Nancy Pelosi. At her recent book signing, which members of Local 798 attended to support our Speaker, I was SHOCKED by the rude behavior of some individuals towards our friend Nancy Pelosi. Let me apologize on behalf of the San Francisco Fire Department for the drama involved in the recent Lieutenant's Test. The Exam Schedule was sent out for August 22-24, 2008. The Fire Department then sends an email that they've changed the date and effectively changed the Test format. Local 798 received many complaints from candidates, at which point Local 798 got involved because of the clear violations of Civil Service rules and the Meyers-

Millias-Brown Act. The Fire Department acknowledged again one of their many mistakes and retreated. The Test is back on the original dates but they are violating their own Test format by having civilians as actors rather than fire-fighters. I guess the adage stands, "... never have a test in the Summer."

Firefighters who are concerned about their careers and the Fire Department asked me "How can this be? My response is that the Administration buys engines that don't work, had to give the Captain's Test twice, and the Battalion Chief's Test may be in litigation - how do you expect them to give a Lieutenant's Test?

We have previously sent a letter requesting that the Testing Unit be removed from the Fire Department's hands. There is enough compelling evidence to support this. Everyone I talk to is in agreement.

Recently the Stress Unit has come under scrutiny. I know of an individual who called the Stress Unit on August 21, 2008 and as of this writing, August 27, 2008, this individual has not had a call back. To clarify, as I understand it, the Stress Unit's sole job is to help firefighters when in need. It is no surprise that the Stress Committee (who provides input and expertise to the Stress Unit) has not met since this Administration has been in place! It goes hand in hand with a Medal Night where firefighters are recognized for acts of bravery; there's been no ceremony since this Administration has been in place! My information is they have lost documentation of our heroic acts, yet for petty disciplines not one shred of documentation has ever been misplaced. Maybe we could use some of our Public Information Officers (PIOs) to fill in these glaring gaps.

I hope each of you will take a moment to reflect on the sudden passing of Firefighter Robert Soberanis from the Airport. Let us all say a prayer for him and his family.

Congratulations are in order to Station One's softball teams. As it has been said by John Shanley, Station One did the "Phelps" thing; they won an open-seated Las Vegas Tournament, returned home to win San Francisco Firefighters Union Softball League, and went on to win the Open and 39 and Over in the California Firefigher Olympics.

It is my understanding that John Shanley and Michael Phelps will meet at Station One to compare gold medals and John will take him on a tour of San Francisco once he returns from the Olympics.





### FROM THE DIRECTOR ...

### **Brotherly Love**

For any firefighter who has worked in the fire service for at least a year, I'm sure you've heard the phrase "this is going to be our year" Whether it's an environment where you fight structure fires or wild land fires, the feeling is the same. Firefighters are complex individuals; we're thrill seekers and innovators, compassionate and competitive. We want the action and none of the accolades that come with the job. We do what needs to be done because it's our job, right?

I have a story that reads differently. It's a story about a group of men who went above and beyond the call of duty to render their help in the form of love, brotherly love.

It was Sunday July 27, 2008, and Northern California was experiencing its third major wild land fire in the months before the projected fire season was to San Francisco had sent strike teams to Shasta/Trinity and Butte County fires, and now I was given an opportunity to fight my first one. Our destination was Mariposa County, and we were all eager to go. With the Strike Team lead by Mike Kearny. we sounded off one by one as we prepared to leave county lines to join thousands of other brothers and sisters in a joint effort to protect others.

Our journey took us from HWY

101 to Mariposa County Fairgrounds, crossing half dozen or so freeways to get there. A four and half hour ride would prove to be an endurance race for some.

Not even an hour into the trip, one of our rigs began to experience computer problems; gauges were going all over the place and quick decisions needed to be made. Based on experience and wisdom of the driver and Officer, it was determined that all should pull over. After further assessment, the decision was made that we continue on, while our Bureau of Equipment (BOE) would

come out and replace the Rig. With a plan in place, and crews ready to go, we continued our trip. However the next incident would prove to be a little more costly.

We had just made the turn to I-99 when

the undeniable smell of radiator fluid made itself known to the crew of Engine 7. With a dejected lump in my throat, I radioed the Strike Team leader once again to request that the team pull over for mechanical prob-

lems. Fearing the worst, we all got off on the next exit.

This is where the true story began. As it turned out, it was only a busted radiator hose, and not the radiator itself. The decision was made to have the

Strike Team continue on their way to base camp, and BOE would have to make the trip to replace the hose; we could join them later. Knowing that our BOE was stretched thin and overworked, one of our members, Sean Bonetti, suggested we call Modesto Fire Department to ask for help. Filled with pride, and a little embarrassed for having to make the call, we reluctantly contacted Modesto FD.

Thanks to the fast work of fire fighters Dwayne Curry, Mariano Elias, and Floyd Rollins, they were able to locate and remove the hose that had ruptured, and were able to describe the situation to our BOE who was returning to 'The City',

> from helping the members from the first breakdown. The hose was a 10" in length, 3" in width shape hose especially built for this engine. Under normal circumstances this would be a 30minute job, but this was not a normal circum-

I love my family, I love my job, and I love working for the members of Local 798, but there comes a time




